#### 2018 Peoria Criminal Record Expungement Summit - Saturday, July 21, 2018 (9am -5pm) at the Peoria Civic Center

Prairie State will be holding another summit in conjunction with Representative Jehan Gordon-Booth's office similar to the summit held last spring. During the Summit, pro bono attorneys will meet one-on-one with Summit participants and advise them on their rights, responsibilities and options relating to their criminal history. Client criminal records will have been obtained and charted by Prairie State. Pro bono attorneys can choose to volunteer all day or pick a shift from 9am-1pm or 12pm-5pm. We still need many more volunteers as we are hoping to serve 300 clients.

Prairie State will provide training for the Summit on Friday June 29th at Heyl Royster from 12-2pm for Free CLE credit for summit volunteers. This training that will cover the 2017 amendments to the Criminal Identification Act and prepare you to volunteer on July 21st.
