The past month has brought the concept of justice into everyday conversations with our family, friends, and neighbors who are not lawyers. As lawyers, our view of justice is typically distinct from what is reported in the press or discussed on social media. Still, during the past month that included the George Floyd trial, and where



various forms of justice and injustice continue to occur, all in too many variants for any one of us to track, it is encouraging that back in 1958 Justice Schwartz of the Illinois Appellate Court penned the following analysis explaining where one may start the analysis to seek justice. The analysis does not fix a destination point. Pondering the quoted words also brings to mind the duties we have as counsel, as elected and appointed representatives, and as judges. While we each have differing views of the facts and even the law, the overarching goal of justice still stands as the goal that each of us strives to attain. The words that follow can help us start off our personal check lists for justice. Moreover, current events inform us of the need to continue our discussions on this subject on a regular basis.

"Justice has been defined by some legal historians as the 'enforcement of covenants.' It has never been considered relevant for one of the parties to plead that he has become distressed by reason of the cost of performance. Other remedies have been provided for such situations. David Hume, whose legal philosophy had great influence in the shaping of the principles embodied in our constitutions, federal and state, laid down three fundamental laws, 'that of the stability of possession,' 'of its transference by consent,' and 'of the performance of promises.' He considered that the peace and security of human society depended upon them and that there was no 'possibility of establishing a good correspondence among men, where these are neglected.' (Hume's A Treatise of Human Nature, p. 526.) Of course, these are only philosophic generalizations and have no effect unless implemented by law. But it is well for those who with rule and line undertake the measure of a court's decision to bear them in mind." *Illinois Cent. R. Co. v. Michigan Cent. R. Co.*, 18 Ill.App.2d 462 (1st Dist. 1958).

In lieu of the cancelled in-person sealing/expungement clinics, PSLS is offering a pro bono opportunity to advise sealing/expungement clients on their record over the phone. PSLS will investigate the client's eligibility to file a Request to Expunge/Seal and if eligible, PSLS will prepare the court documents. We will email the client's documents to you well before you plan to call the client, and we will answer any questions you may have before you call the client. Once you have advised the client over the phone regarding the documents, the client will be empowered to then file the pro se documents. This pro bono commitment typically takes about an hour.

Additionally, PSLS is seeking volunteers to assist clients with uncontested divorces, including uncontested divorces with children.

EVICTION MORATORIUM UPDATE: RENTAL ASSISTANCE IS HERE!

The Illinois Rental Payment Program (ILRPP) is expected to open its rental assistance application portal in May 2021. This program will provide **up to \$25,000** per tenant for rent owed during the time period June 2020 through August 2021. Landlords can apply at <u>www.IHDA.org</u>.
